ACTIONS TAKEN REPORT ON STAKEHOLDER FEEDBACK

A meeting of Academic Monitoring Committee was held under the Chairmanship of Prof. Neelam Jan Shah Principal GDC Beerwah on 25-03-2021. The agenda of the meeting was to discuss the actions taken in the Academic Year 2020-21 on the stakeholders' feedback.

The meeting started with appreciation of the chair to the faculty members and entire college on positive feedback reflected in the stakeholder survey. Following this all the feedback points were discussed one by one, and actions taken in response to each feedback points were discussed in details. The actions taken during the year to strengthen the academic, learning and administrative environment of the college are as following:

1. The class work in the beginning of the academic year had suffered a bit due to late appointment of Academic Arrangement Teachers, which was resolved through discussions with the HED thereby getting teaching faculty for all the Departments.
2. To enhance the articulation in teaching and make teaching process more ICT enabled eight smart boards were procured in 2020-21 and order was placed for more to make each and every classroom smartboard enabled.
3. After the feedback all the faculty members were directed to provide study material to the students, and it was found that most of the faculty members had done so by the end of the Academic Year.
4. To enhance the options of reading and writing, more books were purchased in the library for each subject.
5. The scarcity of classrooms has been addressed with new proposal and approval for the construction of three more classrooms in New Academic Building.
6. To enhance the attendance of students in the college especially of girl students a demand was put forward to DC office for sanction of a bus from the district
